



**RESOLUTION ENDORSED AT A MEETING OF PARENTS OF THE STUDENTS AT CHARLO PRIMARY  
SCHOOL ON 8 NOVEMBER 2023, HELD IN THE SCHOOL HALL AT 18H00.**

**RESOLVED:**

1. The budget for 2024 as indicated, reflects the estimated cumulative effect of habitual tendencies of non-payments and of the total, partial or conditional exemption anticipated to be granted to parents in terms of the Regulations, is approved. The SGB is authorised to redistribute spending within the budget, where necessary, provided that the total budget is not to be exceeded without the consent and authorisation of a parents' meeting.
2. School fees approved at budget meeting held on 8 November 2023:  
**Fees 2024 – Per year R18 150 (Gr 1-7);**  
**Per year R20 350 (Gr RR and Gr R)**  
**Aftercare: Per year R10 780 per year (R980 x 11 months)**
3. Due to school placements being allocated for a full year in advance, school fees are payable in full at the beginning of the academic year and are due on the day which the student takes up the place at the start of that year. The school will therefore accept the following three methods of payments:
  - Upfront (EFT) at the start of the year, prior to February 1<sup>st</sup> - **R18 150 (Gr 1-7); R20 350 (Gr RR and Gr R)**
  - Monthly (by debit order), on the 1<sup>st</sup> of every month (February to December; 11 months) – **an amount of R1 650 (Gr 1-7) OR R1 850 (Gr RR+R)**
  - Monthly (by debit order), on the 25<sup>th</sup> of every month (January to November; 11 months) – **an amount of R1 650 (Gr 1-7) or R1850 (Gr RR+R)**
  - **The deposit that the Gr RR, Gr R, Gr 1 and all other new learners have already paid for 2024 will be deducted from the R20 350 (Gr RR and Gr R)/ R18 150 (Gr 1-7).**
4. In the event of parents failing to adhere to Resolution 3 for a period of 1 month, legal steps will be implemented against them without prior notification, for the recovery of such arrear fees in which event the parents will be liable for legal costs and fees as between attorney and own client including debt collecting commissions which lawfully may become due.
5. The formula for the entire, partial or conditional exemption of parents, who are unable to pay compulsory school tuition, be established in accordance with the benchmark set out in *The Exemption of Parents from School Fees Regulations (as per Government Gazette 29392 of 17 November 2006)*
6. The SGB is sanctioned to make remittance to state employed members of staff in terms of section 38A of the South African Schools Act. The total awarded towards Section 38A payments as indicated in the budget be approved.
